The information we may collect or process and/ or retain may include some or all of the below:

#### How we use the information

#### How we hold your personal data

#### Disclosure of your information

#### Legal basis for processing your data

Our legal basis for the processing of your personal data is our legitimate business interests. # Your rights

## Retention of your data

We understand our legal duty to retain accurate data and only retain personal information as long as we need it for our legitimate business interests and that you are happy for us to do so.

We may hold your data for 12 months after it was last used. After 12 months of non-usage we may contact you to ask if you want to keep your details on our records. If you do not indicate that you wish your details to be retained on our databases/ servers, we will archive your details or delete your records. In order for us to keep your data safe and up to date, prompt responses are required.

We run routine actions to remove data that we no longer have a legitimate business interest in maintaining. We may keep in touch with you so you can let us know of changes to your personal data.

#### Withdrawal of consent
